



Maintenance Agreement

This agreement is made this ____ day of _____ 2013 by and between Blue Atlas Marketing (the "Company") and GOMaximo (the "Customer"), who owns the website located at the domain, gomaximo.org. Company agrees to provide, or cause to be provided, the maintenance services as set forth herein.

SERVICES

Hosting - Blue Atlas provides hosting (storage and serving of website) for client with client control panel and technical support from Blue Atlas and hosting partners. Hosting includes email accounts with webmail and third-party access (such as Outlook) MySQL databases, PHP support, and 1 GB of storage, and 5 GB of bandwidth transfer volume.

Backup & Monitoring - Blue Atlas provides website backup and domain monitoring services for the website at gomaximo.org. Complete backups including database and web files are conducted **once per month** and monitoring is conducted every **5 minutes** to ensure the website is live and responding to server checks.

Updating / Site Maintenance - Blue Atlas will perform all updates and site maintenance as requested by client during each annual cycle. Blue Atlas tracks time spent on updates and maintenance in 1-minute increments for billing purposes. Fees and terms are outlined below.

Up to **12 hours** of service per year

**NOTE: A fee of \$175/hour will be assessed for updates that exceed your contract, billed in 1-minute increments.

SERVICES COST: \$225 per month or **\$2,700** annually

SERVICE FEES AND TERMS

This agreement shall continue for a period of 12 months unless earlier terminated pursuant to the provisions hereof, and shall thereafter automatically renew for successive (1) year periods, unless either party gives proper written notice of cancellation to the other party at least thirty (30) days prior to the end of the initial or any renewal term. To prevent unauthorized cancellations, "proper written notice" means a signed written notice including name, address, and account name. Customer agrees to pay the total monthly fee above plus all sales, service, property, use and local taxes, any access fees, return check charges, or Late Charges, if applicable, whether imposed on Company or Customer.

Prepayment: There is no penalty for prepayment of agreement. A 5% discount will be assessed if full agreement prepayment is received.

Late Fees: A fee of \$5 will be charged for payments for every 10 days past due.
